FFY 2020 LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM**



LIHEAP sign-up for the elderly, 65 years of age and older, and the *legally homebound*, is effective Friday, November 1, 2019. Applicants may CALL-IN* or WALK-IN on FRIDAY, NOVEMBER 1, 2019. *The LIHEAP program is operated on a FIRST COME; FIRST SERVE BASIS AND FUNDING AVAILABILITY. GENERAL PUBLIC CAN NOT APPLY UNTIL MONDAY, DECEMBER 2, 2019.**

To qualify for the LIHEAP Program, applicants must have a yearly household income less than or equal to 60% of the State of Georgia median income guidelines, as defined by the U. S. Department of Health and Human Services. For a one-person household, that would be \$23,776; for two people \$31,092; for three people \$38,408; for four people \$45,724; for five people \$53,040; for six people \$60,356; for seven people \$61,727; for eight people \$63,099; and for each additional person; add \$1,372 in household income. Households approved will receive a ONE-TIME allotment of \$400.00 or \$350.00 towards their home heating source.

All applicants will be asked to provide the following on the date of scheduled appointments:

- Most recent heating bill or statement of service from the heating providers;
- Social Security Cards for each member in the household;
- Proof of Citizenship for each member in the household;
- Proof of income for each member in the household for the last 30 days (Proof of income includes paycheck stubs, a letter granting public assistance, social security or unemployment benefits, etc.); and
- All applicants will be required to sign consent to release information form allowing the state to retrieve energy usage data from their energy provider and to provide proof of bill payment.
