The Low Income Home Energy Assistance Program will open on November 1, 2021

ATLANTA — The Low Income Home Energy Assistance Program (LIHEAP), administered by the Georgia Division of Family and Children Services, will be available November 1, 2021. This federally-funded program assists low-income, elderly and disabled Georgians with heating bills through direct payments to home energy suppliers.

Beginning November 1, 2021, residents aged 65 and older or those who are homebound can apply for assistance through the Department's Low Income Home Energy Assistance Program. All other eligible residents may apply for assistance beginning December 1, 2021. Funds are administered through local Community Action Agencies on a first-come, first-served basis until all funds are exhausted.

To qualify, a family's annual income must be less than or equal to 60 percent of the median income for a Georgia family. For a household of one, the income threshold is \$26,474; the income threshold for a household of five is \$59,057.

Those seeking assistance must contact their local Community Action Agencies. All applicants must provide the following:

- 1. Most recent heating bill or statement of service from their heating providers;
- 2. Social Security numbers for each member of the household;
- 3. Proof of Citizenship for each member of the household;
- 4. Proof of Income for the last 30 days for each adult member of the household;
 - a. Proof of Income can include, but is not limited to, a paycheck stub or a letter granting public assistance, and,
- 5. Social Security or unemployment benefits for all household members, if applicable.

STATE PLAN LOW INCOME HOME ENERGY ASSISTANCE PROGRAM FACT SHEET 2021-2022

The Division of Family and Children Services will provide assistance through four (5) program elements:

- (1) Regular Energy Assistance Program
- (2) Crisis Intervention Assistance
- (3) Cooling Assistance Program
- (4) Weatherization Element

The **<u>Regular Energy Assistance Program</u>** will provide financial assistance on behalf of and to households meeting three requirements:

(1) Income at or below 60% of the state median income level for Georgia.

*For households with nine or more persons, add \$1,527.00 for each additional family member.

- (2) Responsibility for paying the cost of energy for the **primary** home heating source.
- (3) U.S. citizenship or legally admitted alien.

This financial assistance will be primarily in the form of locally issued checks to home energy suppliers on behalf of eligible households. The amount of assistance to both homeowners and non-subsidized renters who receive a bill for their fuel cost will depend on the projected total gross annual household income, household size and payment schedule or increased cost of home heating energy. Subsidized housing tenants whose fuel cost is included in their rental payment are ineligible to receive assistance.

The Regular Energy Assistance benefits will range from \$350 to \$500. This one-time benefit payment is projected to average approximately \$397.67 to approximately 179,258 low-income households. The program will begin to take applications on November 1, 2021, to serve only those households that meet the definition of Medically Homebound or Elderly. The public will be able to apply starting on December 1, 2021.

The program is scheduled to operate until March 31, 2021, or until all funds are exhausted, whichever comes first.

<u>Crisis Intervention Assistance</u> is provided to eligible households after the application is completed within 48 hours and within 18 hours in a life-threatening situation. The applications for assistance are taken at accessible locations statewide, and in the homes of those who are homebound and unable to travel to any of the sites. An emergency opening of the Energy Crisis Intervention Program is determined by severe and unusual weather-related conditions, or crisis situations that result in the loss of or potential loss of fuel services. The Governor, or his/her appointee, or the U. S. Department of Health and Human Services declares all weather-related crisis.

The State will ensure that Energy Crisis Intervention funds are available until March 31, 2022. Financial assistance will be in the form of a vendor check written at the local level. The amount of assistance will be determined by household income, which must be at or below 60% of Georgia's Median Income, the household size, and the household need, up to the maximum benefit of \$500 per household. The eligibility guidelines are the same as with the Regular Energy Assistance Program.

<u>Cooling Assistance</u> will only open during the 2022 summer season if funds are made available. The eligibility requirements as described in the Regular Energy Assistance Program will be used for this component. There will be priority placed on the elderly and homebound during the first week of the program. The benefits approved will be in direct money payments to the provider of their cooling source of energy. Fans and air conditioners are not purchased from LIHEAP funds. The eligibility for cooling assistance is not dependent on eligibility for winter heating. Eligibility will be at or below 60% of the state median income level for this program.

Weatherization activities will be furnished to approximately 600 low-income households. The Georgia Environmental Facilities Authority's Division of Energy Resources currently administers the State Weatherization Program. The low-cost residential weatherization activities will provide direct energy-conserving improvements to the homes of low-income citizens to reduce long term home energy consumption. Priority of services, which include installing ceiling insulation, windows, caulking and weather-stripping is given to the elderly and disabled. Local Weatherization assistance services are provided by local nonprofit organizations. The cost for weatherization of each dwelling must not exceed \$7,776. To be eligible, the household's total income must be at or below 200% of poverty level.
